

Day 1 We will be starting our journey with a trip to the base of the Colorado Rocky Mountains with a flight to **Denver**. Denver is not only the capital of Colorado, but happens to be its largest city in the state. After settling into our hotel all travelers will meet for a delicious welcome dinner and opportunities to get to know other travelers on the tour. Overnight in Colorado Springs or vicinity for 2 nights. (D)

Day 2 We will begin day two by have breakfast at the hotel before heading to the historic town of Manitou Springs, CO. We will get to enjoy a ride on the Pike's Peak Cog Railway. This three hour experience provides some of Colorado's most incredible views, which includes local wildlife as well as sights of trees that are over 2,000 year old. The peak of the vista is approximately 14,115 ft. high. Then we descend down the mountain and visit the Garden of the Gods, a sight so beautiful that it became registered national landmark in 1971. This unique paradise with spectacular red sandstone rock formations and panoramic views would not be complete without a stop at the Garden of the Gods Trading Post. There we can explore Native American culture through art, architecture, and crafts in this one of a kind gift shop designed to resemble a traditional Pueblo Native American home. (B)

Day 5 Our day will begin by traveling on a train from Durango to Silverton. Enjoy a ride on the Durango to Silverton Railroad, is quite historic train and has been in continuous operation since 1882, carrying passengers behind vintage steam locomotives and rolling stock indigenous to the line. The town of Silverton, formally became established in 1885. This historic town is nestled high in Colorado's stunning San Juan Mountains at 9,318 ft. Silverton celebrates a rich mining history with a storied Old West past. (B)

Day 6 Having explored the beautiful mountain vistas the last few days it is time to enjoy the desert scenery as we travel onto Page, Arizona. Explore the beautiful overlooking view of the Colorado river famously known as, Horseshoe Bend. The day would not be complete without first taking a scenic cruise on Lake **Powell** and see some of the amazing canyons this lake is known for. (B, D)

Day 7 Nearing the end of our journey together we will start heading our adventure to Las Vegas, Nevada. Where we will spend our final night of the trip enjoying this exciting city. (B)

Day 8 On our final day we will depart for the Las Vegas airport for our return flight home. Once on board we will have an opportunity to do some reminiscing about the wonders and sights we have seen both natural and manmade that we have experienced on our journey. (B)
