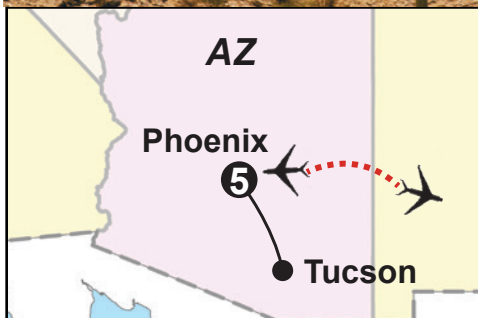

Day 1 Fly to Phoenix (D)

Arrive in Phoenix, the Valley of the Sun, and meet your Tour Manager. Visit Old Town Scottsdale, where Western storefronts create an aura of the past. Transfer to your hotel for a 5-night stay. This evening enjoy a Welcome Dinner with your fellow travelers.

Day 2 Phoenix Sightseeing / Spring Training Game (B)

Day 3 Tucson (B)

Today, travel south for a day of sightseeing in the Tucson area. Visit Saguaro National Park, named for the large saguaro cactus native to this desert environment. Stop at the Visitor Center and travel into the west park area boasting large stands of saguaro cactus creating a breathtaking saguaro forest. Then, visit the 98-acre Arizona-Sonora Desert Museum, a fusion experience of zoo, botanical garden, art gallery, and natural history museum. Enjoy Tucson city sightseeing featuring the Presidio Historic District, the University of Arizona and a visit to Mission San Xavier del Bac, the oldest intact European structure in Arizona

& referred to as the White Dove of the Desert. Return to your hotel for an evening at your own pace.

Day 4 Free Day (B)

The day is at leisure in Phoenix to perhaps enjoy a round of golf, a spa treatment, or lounge by the pool. Maybe go shopping or catch another Cactus League Game on your own. An Optional Excursion will be available.

Day 5 Heard Museum / Spring Training Game (BD)

This morning visit the popular Heard Museum of Native American Culture. Dedicated to the sensitive and accurate portrayal of Native arts and cultures, the Heard is an institution that successfully combines the stories of American Indian people from a personal perspective with the beauty of art. Later attend another Spring Training Baseball Game featuring two Cactus League teams at one of the ten Phoenix area Spring Training ballparks. This evening enjoy an Old West style Farewell Dinner at a fun filled local restaurant.

Day 6 Fly Home (B)

Transfer to the airport & fly home filled with wonderful memories of your Arizona Spring Training Explorer.

FTCC is non-transferable, may not be redeemed for cash and does not include any credit for the Trip Cancellation Waiver Fee. **The Trip Cancellation Waiver Fee must be paid for with Initial Deposit and is refundable until 180 days prior to departure.** The Trip Cancellation Waiver does not cover any single supplement charges due to an individual's traveling companion canceling prior to departure. The Trip Cancellation Waiver is non-transferable and valid for each applicant only. The Trip Cancellation Waiver does not cover any services such as airline tickets not purchased through AFC. Cancellations, Refunds & Inquiries under Part A will be handled by AFC. Certain Exclusions and Restrictions apply.
