**Day 1 Arrive Honolulu, Oahu (D)**  
 Arrive in Honolulu and meet your Tour Manager for a warm Aloha Welcome. Transfer to your hotel and check in for your 3-night stay on Oahu, the most populated of the Hawaiian Islands. Join your fellow travelers for a Welcome Dinner.

**Day 2 Honolulu Touring (B)**  
 Today enjoy a Pearl Harbor & Honolulu City Tour. Head first to Pearl Harbor to take a Navy launch out to the USS Arizona Memorial to pay tribute to the fallen heroes who lost their lives on December 7, 1941. Explore the visitor center, view a film and the exhibits before heading off to see the sights of Honolulu. Set in a real dormant volcano, visit Punchbowl Crater to take a drive through the National Cemetery of the Pacific. Later see the State Capitol, the Governor's Mansion, China Town, and view King Kamehameha's statue before returning to your hotel.

**Day 3 Honolulu at Leisure (B)**  
 Today enjoy a day at leisure in paradise to soak up some sun on the beach or at the pool, do some shopping, play a round of golf or join an optional Oahu Circle Island Tour.

**Day 4 Fly to Hilo / Island Tour (BD)**  
 Fly to Hilo on the Island of Hawaii (the Big Island). Ascend the rugged countryside to Volcanoes National Park, a UNESCO World Heritage site. Visit Volcanoes National Park Visitor Center to learn all about the geology and history of the volcano. Then depart to see the unique Punaluu Black Sand Volcanic Beach. Later journey to the Kona Coast area and check into your resort for a 2-night stay. After settling in, travel to the historic fishing village of Kailua Kona, referred to by the locals as Kona or Kona town. Enjoy dinner in Kona at a popular local restaurant including a choice of a couple of special local brews - a draft from the Kona Brewing Company or an authentic cup of Kona Coffee.

**Day 5 Big Island at Leisure (B)**  
 Relax today in the sun of Kona pool side, maybe

an excursion on your own, play a round of golf, or spend the day shopping.

**Day 6 Fly to Maui (B)**  
 This morning fly to Maui, known as the "Valley Isle". Visit the Maui Tropical Plantation. The Tropical Express offers visitors a 40 minute overview of Hawaii's famous fruits and plants. Later explore Whalers Village in Kaanapali. Then check into your Maui resort for a three-night stay. Enjoy this island paradise with leisure time.

**Day 7 Maui at Leisure (B)**  
 Relax today in the sun of Maui pool side, maybe visit the spa, spend the day shopping, or perhaps join an Optional Whale Watching Cruise Tour.

**Day 8 Maui Touring / Luau (BD)**  
 This morning visit majestic Mount Haleakala National Park or "House of the Sun." Travel to the top of Haleakala, Maui's massive dormant volcano on this scenic journey from sea level to 10,000 feet. At the summit is a vast crater seven and a half miles long by two and a half miles wide, and 3,000 feet deep. Marvel at the crater's eerie landscape of cinder cones and ancient lava formations. This evening join your fellow travelers for a Farewell Dinner and say Aloha to the Islands as you enjoy a Hawaiian Luau, a fun filled cultural event featuring traditional food, dancing and music.

**Day 9 Iao Needle / Fly Home (B)**  
 Today, visit the stunning Iao Valley where spectacular waterfalls and lush tropical foliage surround the Iao Needle, rock formation rising over 2,000 feet from the valley floor. Later, fly home filled with wonderful memories of your Hawaii 3 Island Adventure.\*\*

### DEPOSIT & FINAL PAYMENT

Deposit of \$400 per person is due with Reservation Form to secure reservations. Final Payment Due Date is 90 days prior to departure.

#### Part A - Cancellation Waiver provided by AFC

I. Medical/official documentation required.

II. AFC "Any Reason" Cancellation Waiver (ARCW) - Reimburses 75% of the cancellation fees in the form of a future travel credit certificate (FTCC) valid for 1 year, if you cancel more than 48 hours prior to scheduled departure for any reason not eligible for cash refund under the TCW (Part A - I.). FTCC is non-transferable, may not be redeemed for cash and does not include any credit for the Trip Cancellation Waiver Fee. **The Trip Cancellation Waiver Fee must be paid for with Initial Deposit and is refundable until 180 days prior to departure.** The Trip Cancellation Waiver does not cover any single supplement charges due to an individual's traveling companion canceling prior to departure. The Trip Cancellation Waiver is non-transferable and valid for each applicant only. The Trip Cancellation Waiver does not cover any services such as airline tickets not purchased through AFC. Cancellations, Refunds & Inquiries under Part A will be handled by AFC. Certain Exclusions and Restrictions apply.

#### Part B - Post Departure Travel Protection Plan provided by USI
