Day 1 Fly to Miami, FL (D)
 Arrive at the Miami Airport and meet your Tour Manger. Transfer to your hotel in Ft. Lauderdale for a three-night stay. This evening join your fellow travelers for a Welcome Dinner.

Day 2 City Tour / Cruise (B)
 This morning enjoy a Miami City Tour. See the iconic neighborhood of South Beach, famous for its pastel-colored Art Deco Historic District buildings and its lively oceanfront atmosphere. Continue across the scenic Rickenbacker Causeway to the tropical island of Key Biscayne. Also visit the colorful Cuban heart of the city, Little Havana. Later enjoy a scenic Fort Lauderdale Cruise through the "Venice of America."

Day 3 Everglades / Airboat (B)
 Journey west to the vast wilderness of Everglades National Park, established in 1947 and later designated a UNESCO World Heritage Site. Visit the informative Shark Valley Visitor Center to learn about the "River of Grass." Enjoy a narrated Shark Valley Tram Tour through the wetlands. Spot native wildlife such as alligators, wading birds, and turtles. Then enjoy an exhilarating Everglades Airboat Ride. Skim across the sawgrass in water as low as 6" as your guide shares fascinating stories. Return to your hotel for a free evening.

Day 4 Biscayne / Flamingo (BL)
 Enjoy a scenic drive south to visit the tranquil Biscayne National Park, known for being 95% underwater. Stop at the Visitor Center to learn about vibrant coral reefs, shipwrecks, and rich marine life. Later, enter the Everglades and at the remote Flamingo Lodge have an included lunch. Then stop at the Pa-Hay-Okee Overlook, a scenic tower offering sweeping views of the Everglades. Also visit the elevated Anhinga

Trail Boardwalk, perfect for observing the park's abundant wildlife. Later arrive in Homestead for your overnight stay. The evening is free to enjoy peaceful southern Florida.

Day 5 Overseas Highway / Key West (BD)
 Depart mainland Florida and travel south on US-1. Make a stop on Islamorada and maybe feed the enormous tarpon fish from the docks. Continue along the scenic Overseas Highway and arrive in Key West for a two-night stay. Enjoy a Key West Old Town Trolley Tour highlighting landmarks, historic neighborhoods, and the island's lively Old Town district. This evening enjoy dinner at a local restaurant.

Day 6 Key West at Leisure (B)
 Today is free to explore and enjoy the laid back tropical vibe of Key West. Perhaps you'll visit the Southernmost Point, relax at the beach, and experience a Mallory Square sunset. Maybe take the full day to explore Dry Tortugas National Park by ferry.

Day 7 Key West / Miami (BD)
 Visit the historic Ernest Hemingway Home & Museum, where the legendary American author lived during the 1930s. Built in 1851, the home is famous not only for its literary history but also for its lush tropical gardens and the descendants of Hemingway's distinctive six-toed cats. Later begin the scenic return to the mainland. Enroute, stop on Marathon Key to visit the world-renowned Turtle Hospital. Continue back to the Miami area for your final evening. Enjoy your Farewell Dinner tonight at a local restaurant in Miami.

 Fly home today with wonderful memories.

Part A - Cancellation Waiver provided by AFC

Trip Cancellation Waiver (TCW) - Guarantees full refund on all payments, except the Trip Cancellation Waiver Fee itself in case of cancellation up to the time and date of departure due to the passenger's personal illness or death of an immediate family member. Medical/official documentation required.

II. AFC "Any Reason" Cancellation Waiver (ARCW) - Reimburses 75% of the cancellation fees in the form of a future travel credit certificate (FTCC) valid for 1 year, if you cancel more than 48 hours prior to scheduled departure for any reason not eligible for cash refund under the TCW (Part A - I.). FTCC is non-transferable, may not be redeemed for cash and does not include any credit for the Trip Cancellation Waiver Fee. The Trip Cancellation Waiver Fee must be paid for with Initial Deposit and is refundable until 180 days prior to departure. The Trip Cancellation Waiver does not cover any single supplement charges due to an individual's traveling companion canceling prior to departure. The Trip Cancellation Waiver is non-transferable and valid for each applicant only. The Trip Cancellation Waiver does not cover any services such as airline tickets not purchased through AFC. Cancellations, refunds & inquiries under Part A will be handled by AFC. Certain Exclusions and Restrictions apply.

Part B - Post Departure Travel Protection Plan provided by USI
